# 1 Introduction

This Modern Slavery Risk Management Plan (Plan) outlines Warren Shire Council’s approach to identifying, assessing, and managing the risks of modern slavery within its operations and supply chains. As part of our commitment to ethical governance and compliance with the (NSW) *Local Government Act 1993*, Council seeks to implement reasonable steps to ensure that the goods and services we procure are not the product of modern slavery.

A total of 94 suppliers were invited to participate in a targeted survey developed to assess exposure to modern slavery risks. Of these, 30 suppliers completed the questionnaire. For an additional 17 non-responding suppliers, risk scores were sourced from the LGP’s 2024 Modern Slavery Risk Assessment database, resulting in 47 suppliers being assessed in total.

The Plan identifies procurement categories with the highest potential for modern slavery risk, based on both supplier survey responses and insights from the IRIT. It highlights the need for targeted due diligence in areas where high risk categories intersect with medium to high risk supplier profiles. Suppliers flagged for further assessment have also been identified, with recommendations for Council to conduct an additional round of due diligence using publicly available data and direct supplier engagement.

The Plan serves to guide Council in preventing, detecting and responding to modern slavery risks while also providing transparency and accountability to our local community.

Under the NSW Anti-slavery Commissioner’s Guidance on Reasonable Steps (GRS), Warren Shire Council’s capability level in terms of modern slavery due diligence is determined as low. This means that Council is required to conduct heightened due diligence for procurements with high modern slavery risk, light due diligence for moderate and minimal due diligence for minor and low risk (see Figure 1).

The Plan is also aligned with Council’s existing Risk Management Policy and Plan. It supports the integration of modern slavery risk controls into standard procurement and contract management processes, reinforcing Council’s ethical and legal obligations.

## 1.1 Alignment with Procurement Policy

The modern slavery risk management process outlined in this plan is fully aligned with Council's established Risk Management Policy and Plan. Council recognises that effective risk management is fundamental to achieving the objectives set out in the Community Strategic Plan and delivering services in a way that is ethical, efficient, and accountable.

Council's Risk Management Policy outlines a strong commitment to organisation-wide risk management, guided by the principles of AS ISO 31000:2018 – Risk Management Guidelines. This Policy ensures that risks are consistently identified, assessed, treated, monitored, and reviewed across all areas of Council's operations, including procurement. It reinforces the need to understand both internal and external risks that may impact service delivery, contractual obligations and strategic outcomes, and to embed risk management into all planning and decision-making processes.

Complementing this, Council's Risk Management Plan fosters a risk-aware culture that is applied across all departments, services and functions, including those delivered through third-party arrangements. It highlights the importance of shared responsibility, proactive stakeholder engagement and continuous improvement. The Plan also encourages innovation and ethical governance, supporting the integration of risk management into business-as-usual processes for staff, contractors and partner organisations alike.

Within this context, modern slavery risks, particularly those arising in procurement and supply chains, are managed using the same structured and systematic processes applied to other organisational risks. This includes logical and consistent risk identification, analysis, evaluation, treatment and monitoring. By aligning modern slavery risk mitigation with Council's broader risk management framework, this approach ensures coherence, avoids duplication and strengthens Council's ability to respond to complex ethical risks while fulfilling its responsibilities to the community.

Also, this alignment ensures that modern slavery considerations are embedded throughout Council's procurement activities and across its entire supply chain, thereby ensuring that all business relationships adhere to the highest ethical standards while promoting transparency, integrity and respect for human rights.

## 2 Objectives

The objectives of this Plan are to:

- Identify and assess risks of harm to people arising from modern slavery practices within Council's operations and supply chains.
- Implement strategies to mitigate identified risks.
- Take reasonable steps to ensure the goods and services Council procures are not linked to the exploitation of people, in line with the *Modern Slavery Act 2018 (NSW)*, the GRS and the *Local Government Act 1993 (NSW)* and implement.
- Promote transparency and continuous improvement in managing and reducing modern slavery risks.
- Ensure Council's procurement actions align with human rights principles.

## 3 Scope

This Plan applies to:

- All Council staff, contractors, consultants, temporary (labour hire) staff, Councillors and Council Committees responsible for the procurement or sale of goods, services and works on behalf of Council.

### 3.1 Assessment team

## 4 Risk Management Process

The risk management process outlined in this Plan consists of three key steps designed to help Council identify, respond to and monitor modern slavery risks within its procurement activities. These steps include: (1) risk identification and prioritisation, to determine where the greatest risks lie; (2) development of risk mitigation strategies, tailored to supplier risk ratings and category significance; and (3) setting and measuring performance targets, to track progress and ensure continuous improvement over time. Each of these steps will be discussed in detail in the following sections.

### 4.1 Risk Identification and Prioritisation

This step involves analysing modern slavery risks from two key perspectives. The first is salient risk, based on procurement categories identified as high-risk using the IRIT tool. The second is supplier-specific risk, derived from responses to the LGP Modern Slavery Survey. By combining these two perspectives, Council can prioritise areas where procurement activities may pose the greatest potential risk and focus mitigation efforts accordingly.

### 4.1.1 Salient modern slavery risks

Identifying and assessing salient modern slavery risks in Council's procurement activities is crucial to supporting ethical, transparent, and socially responsible procurement practices. Salient risks are those that have the most severe potential impact on individuals, particularly in categories where supply chains are complex, labour is low-cost and visibility is limited.

Each procurement category carries a different level and type of modern slavery risk and the potential impact can vary in significance depending on various factors such as the nature of the goods or services, the geographic source and the vulnerability of the workforce involved. By focusing on the most significant risks to people, Council can prioritise efforts where the harm is likely to be most serious and take meaningful action to prevent and address exploitation in its supply chains.

To assess the risks associated with Council's procurement activities the following factors were considered.

- What is the Inherent modern slavery risk level of Council's procurement categories?
- How might Council's procurement activities be involved in or connected to modern slavery, either directly or indirectly?
- What level of due diligence is Council required to undertake according to the GRS?

#### Inherent Risk

The inherent modern slavery risk level of each of Council's procurement categories was assessed according to the [IRIT](#).

#### Involved or Connected to Modern Slavery

The following definitions were applied when assessing whether Council might be involved in or connected to modern slavery for each procurement category.

*Causing modern slavery* – Council directly creates or facilitates conditions that lead to modern slavery through its own actions or decisions. For example, Council hires contractors or manages projects that directly exploit workers.

*Contributing to modern slavery* – Council's actions or policies may not directly cause modern slavery but contribute to the conditions that enable it through their procurement practices. For example, Council may unknowingly engage a supplier that uses forced labour in its operations by not thoroughly vetting or monitoring suppliers.

*Directly linked to modern slavery* – Council may be indirectly connected to modern slavery through its procurement activities, partnerships or supply chain even if it is not directly involved in exploiting workers. For example, Council may purchase products from suppliers who have a supply chain that involves modern slavery.

#### Due Diligence Level

This was determined according to Figure 1 in Section 1.

According to the modern slavery risk assessment survey conducted between March and May 2025, the identification of salient risks was based on responses received from suppliers who completed the

questionnaire. The analysis focused only on the supplier categories for which survey data was available, recognising that the insights are representative of those who actively participated in the process. While this provides a valuable snapshot of potential modern slavery risks within Council's supply chain, it is important to note that the assessment does not account for non-responding suppliers. Further details regarding the number of suppliers invited to participate in the survey and the response rate are provided in the following section.

### 4.1.2 Supplier risks

In March 2025, Council engaged Local Government Procurement (LGP) to conduct a modern slavery risk assessment of its suppliers. A survey was distributed to all Council suppliers to gather information on their approach to identifying, managing, and mitigating modern slavery risks within their operations and supply chains. The survey questions were aligned with the *Modern Slavery Act 2018 (Cth)* and the reporting requirements for Australian modern slavery statements. The collected data was analysed and each responding supplier was assigned a modern slavery risk rating - High, Moderate or Low - based primarily on the strength of their existing measures and controls to address modern slavery risks.

The survey was sent to a total of 94 suppliers. Of these, 30 suppliers completed the questionnaire, providing the primary dataset for identifying category-specific modern slavery risks. The remaining suppliers either submitted incomplete responses or did not respond at all.

To ensure broader coverage, we undertook an additional analysis of the non-responding suppliers by cross-referencing them with the LGP's existing modern slavery risk assessment database from 2024. Through this process, we identified 17 suppliers who had previously completed our modern slavery questionnaire. Their existing risk scores were applied to the current assessment to ensure consistency and maximise data utility.

As a result, modern slavery risk ratings were successfully established for 47 out of the 94 suppliers (attached Excel file).

Risk ratings for current Council suppliers have been used to inform the development of some of the mitigation measures in this Plan.

### 4.1.3 Risk Mapping

The mitigation strategies have been prioritised by mapping salient and supplier risks as follows:

## 4.2 Risk Mitigation Strategies

This section outlines both general steps and targeted actions that Council can take to ensure their procurement processes are designed to minimise the risk of modern slavery. It includes baseline measures that should be embedded across all procurement activities, as well as tailored mitigation strategies based on the assessed risk level of Council’s suppliers and the significance of the procurement category.

### 4.2.1 General

The following mitigation measures will be adopted to address modern slavery risks at an organisational level.

## 4.2.2 Heightened Due Diligence

According to [GRS](#), Council is required to undertake heightened due diligence for procurements that have a high modern slavery risk level.

### 4.2.2.1 Priority 1

This priority level covers procurement categories identified as high risk in IRIT, where Council may be contributing to modern slavery risks.

Although no current suppliers in these high risk categories were identified through the survey, these are common procurement areas for councils and therefore warrant attention. Council is strongly encouraged to review its procurement processes to identify whether these categories are relevant and take steps to assess and mitigate associated risks.

For example, the following high risk categories have been flagged in IRIT.

Council should also remain aware of both current and future procurement activities linked to these high risk categories and take appropriate actions to assess and mitigate modern slavery risks.

**4.2.4.3 Priority 5**

This section presents a list of suppliers, along with their associated procurement categories, that have been flagged for further assessment based on Product (Authoritative Determinations) Vulnerable Populations Supply Chain Model Regulatory Context recommended by the IRIT tool. These suppliers fall within categories that often involve both labour and materials that are exposed to varying levels of modern slavery risk.

To strengthen risk evaluation, we recommend that Council undertakes an additional round of due diligence. This would include utilising the GRS resource [Modern Slavery Risks in Construction: An Overview](#) to assist in identifying and assessing the level of risk associated with each individual procurement activity. It may also include reviewing publicly available information—such as company websites, sustainability reports, or corporate disclosures—as well as collecting direct information from suppliers through primary engagement.

### 4.3 Measuring Targets and Identifying Challenges

The effectiveness of this Modern Slavery Risk Management Plan will be assessed through a structured monitoring and evaluation approach. Measurement will occur as follows:

- **Implementation Timeframe:**  
Measurement activities will begin following adoption of the Plan and continue on an ongoing basis as part of regular procurement and contract management processes.
- **Measurement Frequency:**  
Progress will be reviewed annually, in alignment with Council's broader reporting and governance cycles. Additional interim reviews may be undertaken as required, particularly in response to identified risks, supplier non-compliance, or changes in legislative requirements.

Council recognises that identifying and addressing modern slavery risks is a complex and evolving process. The ability to effectively measure progress may be influenced by several challenges, including:

- Limited visibility in complex supply chains, particularly beyond Tier 1 suppliers.
- Supplier capacity and engagement limitations, especially among small or regional suppliers with limited resources or awareness.
- Inconsistent or incomplete data, which can impact the ability to assess and compare performance across procurement categories.
- Changing legislative and regulatory requirements, which may require regular updates to processes, tools and training.

Measurement activities will be reviewed and refined over time to incorporate emerging best practices and to respond to challenges identified during implementation.

Council is committed to a process of continuous improvement. Insights gained through ongoing measurement will inform future updates to this Plan and associated procedures, strengthening Council's overall approach to modern slavery risk management.

## 5 Roles and Responsibilities

While specific responsibilities for each target are detailed throughout the Plan, the following outlines key roles in the overall implementation and oversight of the Modern Slavery Risk Management Plan:

- **Executive Leadership Team** – Provide strategic oversight, approve and adopt the Plan and allocate necessary resources.
- **Procurement Team** – Lead the implementation of the Plan within procurement processes, including risk assessment, supplier engagement, contract management, and data collection for reporting.
- **Contract Managers** – Apply modern slavery risk controls during procurement planning and contract management. Work with Procurement to monitor supplier performance and address any concerns.

- **Governance / Risk / Compliance** – Support procurement in ensuring alignment with legal and Policy requirements and assist with risk monitoring and reporting.
- **Suppliers** – Comply with contractual obligations and participate in due diligence processes.
- **All Staff involved in procurement** – Understand and apply modern slavery risk considerations in procurement activities and report any identified risks or concerns.

## 6 Review

Manex will review this Plan annually, and update it as needed. Additional reviews and updates may occur at any time in response to changes in legislative and regulatory requirements.

Third-party certifications provide independent, objective verification of a supplier’s commitment to ethical practices and human rights, including the prevention of modern slavery.

Examples of certifications addressing modern slavery:

TCO Certified helps guarantee that products are sourced and produced in compliance with international labour standards</p>

## Appendix B

### Guidance for Preparing a Corrective Action Plan (CAP)

*For Small, Medium, and Large Businesses*

This guidance outlines what to include in a Corrective Action Plan (CAP) when modern slavery risks are identified in your organisation or supply chain. A CAP demonstrates your commitment to ethical practices and outlines practical steps to address any gaps.

#### 1. Awareness and Education

**Objective:** Ensure your organisation and supply chain understand modern slavery risks and legal obligations.

**All Businesses Should:**

- Educate staff on modern slavery and their responsibilities.
- Include modern slavery information in onboarding and induction.
- Communicate expectations to Tier 1 suppliers.

**Larger Businesses:**

- Establish structured awareness campaigns and internal communication plans.
- Include modern slavery content in employee learning systems and regular compliance updates.

**SMEs:**

- Use materials like fact sheets or short videos. Relevant resources could be sourced from the [NSW Small Business Commissioner](#), [Australian Government](#), [Australian Red Cross](#) or [Local Government Procurement](#).
- Focus on raising awareness through toolbox talks or short team meetings.

#### 2. Policy Development and Review

**Objective:** Establish clear policies that demonstrate a commitment to human rights, ethical sourcing, and fair work.

**All Businesses Should:**

- Develop and regularly update policies covering:
  - Human rights and labour practices
  - Ethical sourcing
  - Fair employment and payment
- Implement or update a Supplier Code of Conduct aligned with modern slavery expectations.

**Larger Businesses:**

- Ensure alignment with ESG frameworks and global standards (e.g. United Nations Guiding Principles on Business and Human Rights (UNGPs), the International Labour Organisation (ILO)).
- Embed policy compliance into contract terms and audit procedures.

**SMEs:**

- Focus on simple, clear policies and ensure they're communicated to staff and suppliers.

- Use available templates where resources are limited.

### 3. Risk Assessment and Management – Internal Operations

**Objective:** Identify and mitigate risks of modern slavery within your own workforce.

**All Businesses Should:**

- Assess internal risks such as labour hire, low-skilled roles or vulnerable worker groups.
- Establish confidential reporting channels.
- Promote a culture of fair pay, lawful employment and safe conditions.

**Larger Businesses:**

- Conduct formal internal risk assessments and workplace audits.
- Use data analytics or HR dashboards to flag potential issues.

**SMEs:**

- Conduct informal surveys or team check-ins.
- Use simple checklists to review practices like pay, visas and working hours.

### 4. Risk Assessment and Management – Supply Chain

**Objective:** Understand and reduce modern slavery risks across your supply chain.

**All Businesses Should:**

- Assess Tier 1 suppliers for risk based on sector, geography and labour practices.
- Request documentation such as policies, training records or audit results.
- Track and document any corrective actions.

**Larger Businesses:**

- Map the full supply chain beyond Tier 1 (where feasible).
- Engage in third-party audits or certifications for high risk suppliers.
- Implement risk-based supplier due diligence systems.

**SMEs:**

- Focus on Tier 1 supplier relationships.
- Ask key suppliers basic risk questions (e.g. use of subcontractors, sourcing locations).
- Use supplier declarations or adapted checklists.

### 5. Labour Verification and Subcontractor Oversight

**Objective:** Ensure all subcontractors and labour providers are operating lawfully and ethically.

**All Businesses Should:**

- Verify the right to work for all subcontracted or labour-hire staff.
- Include fair work expectations in all labour agreements.
- Apply your Supplier Code of Conduct to all external labour.

**Larger Businesses:**

- Require labour providers to report regularly on compliance (e.g. timesheets, visa checks).
- Use formal onboarding or compliance checks for subcontractors.

**SMEs:**

- Request and retain copies of key documentation (e.g. visa or ID).
- Limit use of unknown or high risk labour hire sources.

## 6. Training and Capability Building

**Objective:** Strengthen the ability of your workforce and suppliers to identify and respond to modern slavery risks.

### All Businesses Should:

- Provide basic training to all relevant staff (e.g. procurement, HR, site managers).
- Offer information or awareness sessions to suppliers.

### Larger Businesses:

- Deliver structured training programs (e.g. eLearning, webinars).
- Evaluate effectiveness through assessments or feedback surveys.

### SMEs:

- Use simple online tools, videos or checklists.
- Seek free or low-cost training options (e.g. from [NSW Small Business Commissioner](#), [Australian Government](#), [Australian Red Cross](#) or [Local Government Procurement](#)).

## What to Include in Your Corrective Action Plan (CAP)

Every CAP should clearly outline:

Section	What to Include
<b>1. Summary of Identified Risks</b>	Describe the risks found in your operations or supply chain.
<b>2. Corrective Actions</b>	Detail the actions you will take, who is responsible and the timeframes.
<b>3. Monitoring and Reporting</b>	Explain how you will track progress and ensure actions are completed.
<b>4. Supporting Documents (Optional)</b>	Attach policies, supplier responses, training records or other relevant materials.
<b>5. Commitment Statement</b>	A short statement signed by senior leadership confirming your commitment.
